1. PROMOTION DESCRIPTION: The *Kellogg's*™ *Nutri-Grain*™ "Getaway From Negotiation" Sweepstakes (the "Sweepstakes") is a social media Sweepstakes that begins on 7/14/21 at 12:00:00 AM Eastern Time ("ET") and ends on 7/28/21 at 11:59:59 PM (ET) (the "Promotion Period").
